Risk Factors relating to the transaction

- To the best of knowledge of the Acquirers, no statutory approvals are required however; it will be subject to all statutory approvals that may become applicable at a later date. The Acquirers reserve the right to withdraw the Offer in accordance with Regulation 23 (1) (a) of the SEBI (SAST) Regulations in the event the requisite statutory approvals for the purpose of this Offer or those that may be necessary at a later date are refused.
- In the event that (a) the regulatory approvals are not received in a timely manner; or (b) there is any litigation to stay the offer; or (c) SEBI instructs the Acquirers not to proceed with the offer, then the offer proceeds may be delayed beyond the schedule of activities indicated in this Draft Letter of offer. Consequently, the payment of consideration to the public shareholders of CTL, whose shares have been accepted in the offer as well as the return of shares not accepted by the Acquirers, may be delayed. The tendered equity shares and documents will be held by the Registrar to the Offer, until such time as the process of acceptance of such equity shares and the payment of consideration thereto is completed.
- In case of delay in receipt of any statutory approval, SEBI has the power to grant extension of time to Acquirers for payment of consideration to the public shareholders of the Target Company who have accepted the Offer within such period, subject to Acquirers agreeing to pay interest for the delayed period if directed by SEBI in terms of Regulation 18(11) of the SEBI (SAST) Regulations.

THE DRAFT LETTER OF OFFER HAS BEEN SUBMITTED TO SEBI FOR A LIMITED PURPOSE OF OVERSEEING WHETHER THE DISCLOSURES CONTAINED THEREIN ARE GENERALLY ADEQUATE AND ARE IN CONFORMITY WITH THE REGULATIONS. THIS REQUIREMENT IS TO FACILITATE THE SHAREHOLDERS OF CAPITAL TRADE LINKS LIMITED TO TAKE AN INFORMED DECISION WITH REGARD TO THE OFFER. THE FILING OF THE LETTER OF OFFER DOES NOT, HOWEVER, ABSOLVE THE ACQUIRERS FROM THE REQUIREMENT OF OBTAINING SUCH STATUTORY CLEARANCES AS MAY BE REQUIRED FOR THE PURPOSE OF THE OFFER.

3. DETAILS OF THE OFFER

3.1 Background of the Offer

- 3.1.1 The Offer is being made under Regulation 3(1) and 4 of SEBI (SAST) Regulations and as a result of this Offer, the Acquirers will have substantial acquisition of shares or voting rights accompanied with complete change in control and management of "CTL".
- 3.1.2 The Acquirers in aggregate holds 50,71,000 equity shares representing 10.14% of the total paid up share capital of target company.
- 3.1.3 The "Acquirers" and "Sellers" have entered into the share purchase agreement on December 03, 2013, pursuant to which and subjected to the satisfaction or waiver, if applicable, of the conditions contained in the SPA, the Sellers have agreed to sell, and

the Acquirers have agreed to purchase in cash 83,69,000 equity shares representing 16.74% of the total issued and paid up equity share capital of the target company at a maximum price of Re 1/- (Rupees One Only) per equity shares (the "Sale Shares") from the Sellers. The Sellers are Promoters/ Promoter Group of the Target Company and are in management control of the Target Company. The completion of acquisition of shares under the SPA shall be done in compliance with Regulation 22(1) of the Regulations.

3.1.4 The important features of the SPA are laid down as under:

- In consideration of the purchase of the shares, the Acquirers shall pay total cash consideration of Rs 83,69,000/- (Rupees Eighty Three Lacs Sixty Nine Thousand only).
- Against payment of the sale consideration, the Sellers as the legal and beneficial owners of the shares, shall sell, transfer, convey and deliver to the Acquirer and the Acquirer shall purchase and acquire from the sellers, shares free from all encumbrances, all rights, title and interests of the Sellers in the shares together with all accrued benefits, rights and obligations attaching thereto.
- The Acquirers undertakes and covenant to take all steps and actions as may be necessary for compliance with the provisions of the Takeover Code. The sellers agree to provide the Acquirer with all necessary support, for complying with the provisions of the Takeover Code relating to Public Offer as are applicable to the transaction envisaged herein.
- In the event the Acquirers fail to comply with the applicable provisions of the Takeover Code relating to the Public Offer, the SPA shall stand terminated and shall be null and void.

3.1.5 Neither the Acquirers, Sellers nor the Target Company have been prohibited by SEBI from dealing in securities, in terms of direction under Section 11B of the SEBI Act or under any of the Regulations made under the SEBI Act.

3.1.6 The Acquirers may, after completion of transaction of sale shares and in Compliance with Regulation 22(1) of the SEBI (SAST) Regulations, reconstitute the Board of Directors of the Target Company by appointing their representatives, as they may deem fit. As on date, the Acquirers have not decided on the names of persons who may be appointed on the Board of Directors of the Target Company.

3.1.7 The Board of Directors of the Target Company shall, in accordance with Regulation 26(6) of the SEBI (SAST) Regulations, constitute a committee of independent directors who would provide its written reasoned recommendation on the Offer to the Shareholders of the Target Company. In accordance with Regulation 26(7), the committee of independent directors of the Target Company shall provide their reasoned recommendations on this open offer to its shareholders and the Target Company shall in accordance with Regulation 26(6), cause to publish such recommendation at least two working days before the commencement of the tendering period i.e. on or before Wednesday, February 12, 2014, in the same newspapers where the DPS of the Offer was published.

3.2 Details of the Proposed Offer

3.2.1 A Detailed Public Statement, as per Regulation 14 (3) of the SEBI SAST Regulations, was made in the following Newspapers, on December 10, 2013:

3.2.2 The Acquirers are making an Offer in terms of Regulation 3(1) and 4 of the SEBI (SAST) Regulations, 2011, to acquire 1,29,94,800 equity shares of Re 1/- each fully paid up representing 26% of the share/voting capital of "CTL" at a price of Re 1/- (Rupee One Only) per fully paid up equity share ("Offer Price") payable in cash, from the public shareholders of target company other than the acquirers and the parties to the share purchase agreement including persons deemed to be acting in concert with such parties, and subject to the terms and conditions set out in the Public Announcement, Detailed Public Statement and this Letter of Offer.

- 3.2.3 The Offer Price is Re 1/- (Rupees One Only). As on date of this Letter of Offer, all the equity shares of the Target Company are fully paid up and there are no partly paid up equity shares in the Target Company. There are no outstanding convertible instruments (debentures/warrants/FCDs/PCDs) etc. into equity shares on any later date.
- 3.2.4 There is no differential pricing for the shares proposed to be acquired under the open offer.
- 3.2.5 This is not a Competing Offer.
- 3.2.6 All the shares tendered shall be free from lien, charges and encumbrances of any kind, whatsoever.
- 3.2.7 The Offer is not subject to any minimum level of acceptance from the shareholders i.e. **it is not a Conditional Offer** and the Acquirers will be obliged to acquire all the equity shares tendered in response to the Offer, subject to a maximum of 1,29,94,800 Equity Shares that are tendered in the valid form in terms of the Offer subject to the terms and conditions mentioned in the DPS and the Letter of Offer ("LOO") to be mailed to the shareholders of the Target Company.
- 3.2.8 The Acquirers has not acquired any shares of the target company from the date of public Announcement upto the date of this Draft Letter of Offer.
- 3.2.9 The Acquirers in aggregate holds 50,71,000 equity shares representing 10.14% of the total paid up share capital of target company and have not acquired any shares from the date of public announcement till the date of this draft Letter of Offer.
- 3.2.10 The Acquirers at present have no intention to sale, lease, dispose of or otherwise encumber any significant material assets of target company or any of its subsidiaries in the succeeding two years, except in the ordinary course of business of target company. However target company's future policy for disposal of its material assets, if any, or any of its subsidiaries will be decided by its Board of Directors, subject to the applicable provisions of the law and subject to the approval of the shareholders of target company, by way of postal ballot and the notice of such postal ballot shall contain as to why such disposal is necessary, in terms of provisions of Regulation 25(2) of the SEBI (SAST) Regulations, 2011
- 3.2.11 The acquisition of 26% of the paid up equity share capital of target company under this offer together with the equity shares being acquired in terms of share purchase agreement will not result in public shareholding in CTL being reduced below the minimum level required for the purpose of continuous listing under clause 40A of the Listing Agreement and read with Rule 19A of the Securities Contract Regulations/Rules, 1957 ("SCRR"). Assuming full acceptance under this offer, the post offer holdings of the acquirers shall not go beyond the maximum permissible non public shareholding under SCRR and in case the holding of the acquirers goes beyond the limit due to further acquisitions, the acquirers hereby undertakes to reduce their shareholding to the level stipulated in the SCRR and within the time specified therein and through permitted routes available under the listing agreement including any other such routes as may be approved by SEBI from time to time.

3.3 Object of the Acquisition/ Offer

- 3.3.1 The Acquirers are interested in taking over the management and control of CTL. Thus substantial acquisition of shares and voting rights accompanied with change in control and management is the reason and rationale for the offer. At present, the acquirers have no intention to change the existing line of business of target company.
- 3.3.2 The acquirers will continue the existing line of business of Target Company.

- 4.1.4 Mr. Prashant Goel, Chartered Accountant (Membership No. 421572) partner in Nitin Mittal & Company, Chartered Accountants, having office at Ground Floor, C-21B, South Extension-1, New Delhi- 110049, has certified vide his certificate dated November 14, 2013 that the Net worth of M/s Krishan Kumar & Sons (HUF) as on November 01, 2013 is Re 224.07 lacs and further the letter also conforms that M/s Krishan Kumar & Sons (HUF) has sufficient means to fulfil its part of obligations under this offer.
- 4.1.5 As per declaration received from Krishan Kumar & Sons (HUF), Presently there is no litigations pending against it.

4.2 ACQUIRER NO.2 - M/s Neeraj Kumar & Sons (HUF)

- 4.2.1 M/s Neeraj Kumar & Sons (HUF) is the Hindu Undivided Family and incorporated on May 04, 1997. Mr. Neeraj Garg is the Karta of Neeraj Kumar & Sons (HUF).
- 4.2.2 Neeraj Kumar & Sons (HUF), an acquirer to the said offer has not been prohibited by SEBI from dealing in securities in terms of section 11B of the Securities and Exchange Board of India Act, 1992, as amended ("**SEBI Act**").
- 4.2.3 Neeraj Kumar & Sons (HUF) presently holds 25,71,000 number of equity shares representing 5.14% of the total paid up share capital in the Target Company as on the date in the target Company. The Provision of Chapter V of the SEBI (SAST) Regulations, 2011 are applicable to it and it has complied with the provisions of Chapter V of SEBI (SAST) Regulations, 2011.
- 4.2.4 Mr. Prashant Goel, Chartered Accountant (Membership No. 421572) partner in Nitin Mittal & Company, Chartered Accountants, having office at Ground Floor, C-21B, South Extension-1, New Delhi- 110049, has certified vide his certificate dated November 14, 2013 that the Net worth of M/s Neeraj Kumar & Sons (HUF) as on November 01, 2013 is Re 378.72 lacs and further the letter also conforms that M/s Neeraj Kumar & Sons (HUF) has sufficient means to fulfil its part of obligations under this offer.
- 4.2.5 As per declaration received from Neeraj Kumar & Sons (HUF), presently there is no litigations pending against it.

5. BACKGROUND OF THE TARGET COMPANY

CAPITAL TRADE LINKS LIMITED (CTL)

- 5.1 Capital Trade Links Limited (hereinafter referred to as "CTL"), was incorporated as a Public Limited Company on December 19, 1984 with the Registrar of Companies, NCT of Delhi and Haryana. Presently the Registered Office of the Company is situated at 101-102, 1st Floor, Rohit House, 3 Tolstoy Marg, Connaught Place, New Delhi- 110001. The Company does not belong to any group.

6.2.6 Mr. Prashant Goel, Chartered Accountant (Membership No.421572) partner in Nitin Mittal & Company, Chartered Accountants, having office at Ground Floor, C-21B, South Extension- 1, New Delhi- 110049, has Certified vide his certificate dated November 14, 2013, based on the information available, that the Acquirers have adequate resources and capability to meet their respective financial obligations under the Offer.
